

## Harbor String Quartet Contract of Service

This contract, for the personal services of the below named musicians, of 1835 Tree Line Rd. Virginia Beach, VA 23454, herein called ARTIST, on the engagement described below, made this date \_\_\_\_\_ between the undersigned purchaser of services, herein called PURCHASER. ARTIST is engaged on the terms and conditions hereof, and agrees to be bound by the terms and conditions.

THEREFORE, it is mutually agreed between the parties hereto as follows:

7. PAYMENT TERMS:
  - a. PURCHASER will render a deposit check for \$ \_\_\_\_\_, payable to Harbor String Quartet at least 30 days prior to the engagement, to hold the date and to act as earnest money. (Please note: Your date and time is not reserved until contract and deposit have been received.)
  - b. PURCHASER will render remaining amount due upon the ARTIST arrival at place of engagement payable to the individual musicians to be named.

8. PURCHASER shall make arrangements to take care of ARTIST'S technical needs, which in this case are:
  - a. Sufficient performing space (approx. 10' x 8') where ARTIST view ceremony.
  - b. Sufficient lighting.
  - c. Four armless chairs.
  - d. Outdoor temperatures must be between 60 degrees and 90 degrees with shelter from rain and direct sunlight.
9. If, in the case that one member of the ARTIST (s) cannot perform, due to circumstances beyond ARTIST'S control (e.g. illness, death in the family, etc.) then ARTIST will be replaced by another ARTIST of equal performing ability.
10. If in the case that PURCHASER cancels or postpones the engagement, without written notice to ARTIST later than fifteen (15) days prior to the engagement described herein, then PURCHASER shall pay ARTIST the full wage agreed upon herein. If written notice is extended to ARTIST between thirty (30) and fifteen (15) days prior to engagement, then, the deposit shall be retained by ARTIST. If PURCHASER render written notice of cancellation with more than thirty (30) days prior notice then PURCHASER shall be held blameless and unaccountable.
